

















Executive Summary:

BHS Clarion Hospital is proud to present its 2021 Community Health Needs Assessment (CHNA) Report. This report summarizes a comprehensive review and analysis of health status indicators, public health, socioeconomic, demographic and other qualitative and quantitative data from the primary service area of Clarion Hospital.

The data was reviewed and analyzed to determine the top priority needs and issues facing the region overall, and each individual hospital service area.

The primary purpose of this assessment was to identify the health needs and issues of the community defined as the primary service area of the hospital. In addition, the CHNA provides useful information for public health and health care providers, policy makers, social service agencies, community groups and organizations, religious institutions, businesses, and consumers who are interested in improving the health status of the community and region. The results enable the hospital, as well as other community providers, to more strategically identify community health priorities, develop interventions and commit resources to improve the health status of the region.

The full report is also offered as a resource to individuals and groups interested in using the information to inform better health care and community agency decision making.

Individually and collectively, improving the health of the community and region is a top priority for BHS Clarion Hospital. Beyond the education, patient care and program interventions provided by the hospital, we hope the information presented is not only a useful community resource, but also encourages additional activities and collaborative efforts that improve the health status of the community.

2018 Community Health Needs Assessment Follow Up

In March 2021, Clarion Hospital conducted a 3-year evaluation of its CHNA implementation strategies from the 2018 assessment.

The 2018 Clarion CHNA identified 3 goals that included: implement physical activity and nutrition programs/education to address the obesity epidemic, improve diabetes care management, and improve and expand substance abuse and behavioral programs. Within the short time frame, it is impossible to determine if the implementation strategies impacted any of the county-wide indicators. However, great strides were made in continuing to expand wellness programming both at the hospital and around the community. The hospital focused on enhancing physical activity and nutrition within the community through their outreach programs in the school systems, business and industry sector, and the community at large. Outreach programs that addressed the physical activity and nutrition needs included: Teddy Bear Clinic, Health Wise @ Work, Senior Wellness Expo, Women's Expo, Multiphasic Blood Screening, Health Wise Employee Wellness Program, and participation in several health fairs. The addition of 2 new outreach programs, Lifestyle Coaching and Physician Lunch & Learn Events, added to the efforts of enhancing healthy lifestyles within our community to address the obesity epidemic.



As part of the evaluation process of the implementation strategies, it should also be noted that due to the implications of the COVID 19 pandemic beginning in March, 2020, several community outreach events and initiatives were put on hold for safety reasons. These safety restrictions have continued into 2021 and have further limited our ability to continue many of the programs that are regularly implemented to address the health needs of our community.

Short term outcomes from the intervention activities to date include:

The last Community Health Needs Assessment was completed in March, 2018. As a part of this process, an evaluation of the CHNA Implementation Strategies is conducted to evaluate the effectiveness of the programs that are being implemented to address the identified needs. These programs include: Teddy Bear Clinic, Senior Wellness Expo, Health Wise Employee Wellness Program, Diabetes Education, Women's Expo, Health Wise @ Work Program, Multiphasic Blood Screening, Lifestyle Coaching Seminars, Physician Lunch & Learn Events and Armstrong Indiana Clarion Drug & Alcohol Commission ARMOT program.

<u>Teddy Bear Clinic</u>: During the 2018-2019 and 2019-2020 fiscal years, the hospital team conducted this program at 9 different school districts working with approximately 827 students and 40 educators. The students and teachers are being taught the importance of healthy eating and exercise. At the end of each session, the students are asked questions pertaining to the information that is being taught. The responses given by the students and teachers indicated learning had occurred and they were given the tools to promote positive changes in the areas of nutrition and physical activity.

Senior Wellness Expo: This event attracted over 450 people during the fiscal years of 2018-2019 and 2019-2020. Normally this event is held twice a year but was cancelled in the Fall, 2018 due to inclement weather. The goal of this event is to provide seniors with health and wellness education/awareness that is specific to their age group. It also provides much needed socialization, entertainment, and a nutritious meal to the attendees. The hospital staff has been involved with the planning of these events and many have made presentations on health related topics such as diabetes education, senior exercise and fitness, sleep quality, bone health, healthy cooking, cancer prevention and treatment, depression/anxiety, grief and loss, and intimacy for seniors. At the end of the event, the seniors are asked to complete a survey which includes questions about the impact of the event. Over 50% indicated a positive impact on their lifestyle and overall well-being.

<u>Wise Employee Wellness Program</u>: This was a pivotal time period for the Health Wise program at Clarion Hospital as we continue to show growth in employee engagement. With the opening of the new Clarion County YMCA and the improvements to our biometric screening program in 2019, increasing numbers of employees participated in the wellness program. Our fitness classes at the hospital were discontinued due to lack of space and room availability, but employees were encouraged to participate in the fitness classes at the YMCA offering cash back incentives.

Furthermore, the new YMCA is located less than 1 mile from the hospital and offers 20+ fitness classes per week plus a wide variety of exercise equipment and fitness opportunities. Over 60 employees and their families have taken advantage of the corporate membership program which offers discounted membership rates. The hospital also reimburses 50% of the

yearly membership to those employees who reach 140 visits or more in a calendar year. Our 2019 Wellness Rewards Program showed significant increases in employee participation. It included a biometric screening, on-line health risk assessment, and a preventative exam with the employee's health care provider. With the addition of a health insurance savings incentive, we had an 80% participation rate in our 2019 and 2020 wellness rewards program as compared to an average of a 20% participation rate the previous 3 years.

Also included in the Health Wise program were our quarterly Lunch and Learn Programs, a "5 for 5" nutrition and fitness program, our Biggest Loser challenge, and the employee fitness center. We averaged 20-25 people in our Lunch & Learn programs, 80 participants in the"5 for 5" program, 140 in the Biggest Loser Challenge and 5-10 people/week took advantage of the employee fitness room.

The "Health Wise @ Work" program, under the umbrella of Health Wise, continued to work with the area's business and industry sector by offering health screenings and education to their employees. We provided services to one outside company, working with 70+ employees. We hope to expand these services to other businesses by promoting the value of improved health and productivity for their employees.

<u>Multiphasic Blood Screening</u>, <u>Health Fairs</u>, <u>and Women's Expo</u>: Multiphasic Blood Screening event at Clarion Hospital continued to reach a great number of people within the community with participation numbers at 1,078. This is offered twice a year in conjunction with the Clarion Rotary Club and offers community members an opportunity to receive a blood screening at minimal cost while sharing the results with their primary care providers for follow-up care.

The hospital also participated in various health fairs within its service area, reaching 426 people with the screenings they offered including blood pressure, blood glucose, and cholesterol. Furthermore, they provided education on diabetes, hypertension, nutrition, Lyme's Disease, and other health and wellness services Clarion Hospital has available.

The Women's Expo is an annual event sponsored by the hospital to offer health and wellness education and services to the female population in the community. In 2019, the program featured presentations by an Ob/Gyn physician and Plastic Surgeon focusing on women's health for all ages. There were 78 participants for this event.

Physician Lunch & Learn Events: The Clarion Hospital has organized and hosted multiple educational sessions and outreach events related to orthopedic injuries and ear, nose and throat conditions. Members of the community and area medical practices were invited to attend these seminars to expand their knowledge and gain information about these topics. There were more than 100 community residents that participated in these informational sessions to determine how their health care needs could be met in the areas of orthopedics and ear, nose and throat specialties.

<u>Lifestyle Coaching Seminars</u>: Multiple nutritional and/or weight management events were offered to the community, led by a registered dietician. Topics included: Plant Based Diet, Mediterranean Diet, Heart Health, the DASH Diet, Eating for Energy, and Weight Management. These sessions included tips and factual information as well as healthy recipes and informational booklets that the participants could take home. Over 80 community members (some of which were hospital employees) participated in these seminars.

<u>Physician Lunch & Learn Events</u>: The Clarion Hospital has organized and hosted multiple educational sessions and outreach events related to orthopedic injuries and ear, nose and throat

conditions. Members of the community and area medical practices were invited to attend these seminars to expand their knowledge and gain information about these topics. There were more than 100 community residents that participated in these informational sessions to determine how their health care needs could be met in the areas of orthopedics and ear, nose and throat specialties.

Behavioral Health and Substance Abuse/Addiction

Armstrong Indiana Clarion Drug & Alcohol Commission ARMOT Program: Clarion Hospital partners with this group to provide screenings, assessments and referrals for patients that exhibit signs and symptoms of drug and alcohol dependency. The ARMOT (Addiction Recovery Mobile Outreach Team) staff provides these services along with drug and alcohol education to area schools, hospitals, and other businesses and organizations within the community. During this time, Clarion Hospital made 85 referrals to ARMOT, 61 individuals were screened, 21 were assessed, 3 refused services, 17 went to treatment and 2 were discharged prior to meeting with the ARMOT staff. The hospital is also making efforts to work closer with this group for expansion of drug and alcohol services and to establish a more effective partnership. Several meetings have taken place to work toward this goal.

2018

An educational program relative to Trauma Informed Care & Sensitivity Training was held November, 2018-December 2018. This educational program was provided in collaboration with Dr. Mark Lepore of Clarion University of Pennsylvania and Mr. David Delvaux from Clarion Psychiatric Facility. The education was required for all Clarion Hospital employees.

Jan 2019

A meeting was held with Special Care (detox services) and the Department of Health Division of Drug & Alcohol to discuss potential waiver requests necessary in order to move forward with the service. Special Care will be drafting potential waiver language for us to utilize in the process. This project was not realized as a result of PaDOH requirements for the hospital to have an entire unit that was dual approved by DAAC and Behavioral Health.

We completed education relative to Opioid Use Disorder pathways for the Emergency Department and provided attestation of the developed pathways to the Department of Human Services (DHS).

- 1. ED initiation of buprenorphine with warm hand off to the community;
- 2. Direct warm hand off to the community for MAT or abstinence based treatment;
- 3. Specialized protocol to address pregnant women with OUD; and
- 4. Direct inpatient admission pathway for methadone or observation for buprenorphine induction.

2019-2021

Participation in ARMOT Meetings by ED Nurse Manager and Social Worker.

<u>Sept/Oct 2020</u>

Suicide Risk Assessment and questions were developed and added to ED and Inpatient patient assessments.



Staff education on the use of the assessment and appropriate follow-up occurred.

Sept 19 - Present

Developed and submitted Grant proposal for PA Action Coalition relative to OUD and nursing education. \$5000 grant approved for implementation in 2020 (with extension provided through May 2021 r/t COVID 19 Pandemic):

Clarion Hospital proposes to improve community health by addressing issues associated with health care disparities relative to individuals affected by Opioid Use Disorder (OUD). Individuals are often unable to access and receive quality treatment as a result of socioeconomic factors and stigma associated with the disorder. SAMHSA reports that individuals affected by substance use disorder also report a history of childhood abuse and/or trauma.

This project will focus on the education of nursing staff regarding the care, treatment, and screening of patients with OUD in order to support a more informed and caring workforce. The education will focus on the science of addiction and principles of Trauma Informed Care. Collaboration with community partners is included to ensure effective transition of care into the community.

The community need is met by improving access to services and quality of care for patients affected by OUD. The Hospital's 2018 Community Health Needs Assessment (CHNA) evaluated demographics, socio-economic indicators, access to care, chronic disease, environment, and substance abuse, among other areas. The CHNA included qualitative and quantitative data from focus groups, surveys, the steering committee, and secondary public health data; identifying substance abuse as a top priority.

- Implemented OUD Screening tool in the ED
- Staff education of the screening tool
- Trauma Informed Education module for ED staff with pre/post test

Diabetes

2018

Diabetes Health Fair was held November 14th observing National Diabetes Day. Over 100 attendees were able to visit with our 38 vendors throughout the facility and engage in learning about diabetes management tools.

Monthly Classes were held in 2018 with additional individual sessions for participants that needed more of a 1 on 1 approach. 323 patients were seen in 2018

Continued to offer Diabetes Support Group Held every other month for anyone seeking help coping with diabetes



Diabetes Alert Day – March 26th – Diabetes Risk Assessments were completed on individuals during the course of the day. Promoting awareness of diabetes

Participated in the Senior Wellness Event – diabetes educator and registered dietician attended the event with 250 seniors, educating them on the risks of diabetes and encouraging them to participate in the diabetes education classes held monthly at the hospital.

2019

Diabetes Health Fair was held November 14th observing National Diabetes Day. Over 100 attendees were able to visit with our 32 vendors throughout the facility and engage in learning about diabetes management tools.

Monthly Classes were held in 2019 with additional individual sessions for participants that needed more of a 1 on 1 approach. 293 patients were seen in 2019

Continued to offer Diabetes Support Group held every other month for anyone seeking help coping with diabetes

Diabetes Alert Day – March 26^{th} – Diabetes Risk Assessments were completed on individuals during the course of the day. Promoting awareness of diabetes

Developed Diabetes Class for CDL Drivers held April 6 & 16, 2019 - ADA Diabetes Self-Management Education 6 hour class geared toward understanding the challenges and barriers as a truck driver with diabetes. Whether an individual is an over the road driver who is away from home for extended periods of time, or a driver who is home daily there are many unique challenges. Class is focused on understand the PennDot exemption and requirements for Insulin use, monitoring blood glucose and documentation laws, and the latest technology that is available to assist in diabetes management. There were 12 total participants for this class. Diabetes Boot Camp was developed held in August of 2019 – this six hour session included all of the ADA components for Diabetes Self-Management Education with a large focus on understanding diabetes, nutrition and overall management. This class was created for people who could not make the four day courses.

Senior wellness Event – diabetes educator and registered dietician attended the event with 250 seniors, educating them on the risks of diabetes and encouraging them to participate in the diabetes education classes held monthly at the hospital.

COVID-19

As part of the evaluation process of the implementation strategies, it should be noted that due to the implications of the COVID-19 pandemic beginning in March, 2020, several community outreach events and initiatives were put on hold for safety reasons. These safety restrictions have continued into 2021 and have further limited our ability to continue many of the programs that are regularly implemented to address the health needs of our community. Furthermore, many of the outreach initiatives had to be adjusted and shifted due to the new challenges that the hospital and



community were faced with in light of the pandemic. The information presented below will expand on the impact of the COVID-19 pandemic on the health and wellness of our hospital and community at large.

The following data outlines the impact of COVID-19 on Clarion County as of April 30, 2021.

- 1,971 confirmed cases of COVID
- 91 deaths
- 13,107 COVID PCR tests performed
- 5,795 Rapid Stars Antigen tests

On a positive note, the hospital was able to partner with the local county government and DOH to administer over 25k vaccines since December of 2020. The hospital and health system experienced declines of emergency visits as high as 20% and for long periods of time elective procedures were put on hold, causing significant financial hardship for the system.

While Clarion Hospital and Butler Health System quickly pivoted to meet the changing needs for access to care (such as a robust telemedicine response), as well as virtual platforms for public health education and lifestyle coaching, the mental health exacerbations due to financial hardship and health impact of postponing routine care are expected to present new challenges for us as we enter the post-pandemic era.

As COVID-19 spread across the US in 2020, emergency room visits declined steeply. An analysis of data from the National Syndrome Surveillance Program demonstrated a 42% decrease on overall weekly emergency room visits nationwide. Other studies showed a substantial decline in volume relative to 2019, including decreases in presentation for syncope, CVA, MI, pneumonia, and exacerbation of COPD and heart failure.

Furthermore, mental health implications that occurred during the pandemic may stem from many psychosocial factors such as:

- Fear of infecting family members
- Lack of access to testing and medical care
- Physical distancing, home confinement, quarantining, and loneliness
- Inconsistent messaging regarding public health measures such as mask wearing
- Increased workloads
- Economic hardship and insecurity
- Shortages of available resources- food, paper products, personal protective equipment
- Continual media reports about the pandemic and the uncertainty surrounding its eventual outcome

Other mental health issues included those patients with pre-existing psychiatric conditions, prior to the pandemic, who experienced deterioration of their illness due to delayed or interrupted care with their clinicians. Patients were unable to obtain refills and may have been forced to reduce medication dosage or stop them altogether. Some patients may have not had the opportunity to see their clinician for adjustments to medications if they were ineffective or causing adverse side effects.



Additional challenges for our health system included our efforts to keep our patients and staff safe while maintaining our quality of service:

- Low hospital enrollment
- Non-essential healthcare employees working remotely
- Outpatient testing put on hold
- Elective procedures were put on hold
- Outpatient provider appointments were moved to virtual
- Many of our outreach efforts focused on providing employee support and adjusting community services to a virtual format:
- Virtual workforce support groups for employees
- "No one Dies Alone" program
- "Feeding our Heroes" initiative- partnership with local restaurants, food vendors and local nonprofits to provide funding for meals to frontline workers of the COVID-19 pandemic.
- Virtual Lifestyle Coaching classes with new content, marketing strategies and adaptations specific to the pandemic
- Compassion Care Rounds for patients who were admitted to the hospital when visitors were not allowed. The health system initiated the use of tablets for patients to connect with their loved ones

In finalizing the content of the COVID-19 implications surrounding the community health needs assessment, it is important to note that this pandemic has created an increased awareness of social determinants of health and the need for community-integrated care. In January, 2021, the health system developed a new position of Chief Community Health Officer to focus on initiatives specific to social determinants of health.

2021 Community Health Needs Assessment

This community health assessment was conducted throughout the spring and summer of 2021. Qualitative and quantitative data was gathered from community members, and stakeholder organizations in the Clarion County region. Employees and providers of BHS Clarion Hospital, along with other multiple secondary data sources.

Methods

The assessment committee gathered input from individuals and organizations that represent the broad interests of the Clarion region; this was completed through a range of methods.



- Multiple meeting were held with the BHS Clarion Community Assessment team to identify the top health priorities within the primary service area of Clarion County.
- BHS Clarion collected health data from County Health Rankings, Centers for Disease Control and Prevention, World Life Expectancy, PAYS, and US Census.
- 323 community members completed electronic and paper surveys to provide additional data to the survey the health of the people in the Clarion County Region. Along with 13 completed stakeholder surveys.
- Focus groups met and discussed the data collected from all the sources above. The main themes that arose throughout the discussion were mental/behavioral health, food insecurity, and access to care, transportation, COVID-19, substance abuse, diabetes, obesity, and child care.

Population Served




Figure 1: Clarion Hospital Primary Service Areas

The primary service area for BHS Clarion Hospital was identified as Clarion County, Pennsylvania. A majority of patients and visits originate from the Clarion and surrounding counties. The individuals that come from surrounding counties to receive more advanced services include: Venango, Forest, Armstrong, and Jefferson. For the purpose of secondary data collection, Clarion County was determined to be the community served. This is illustrated in figure 1

Health Factors and Outcomes

Data surrounding the health factors and outcomes was evaluated using County Health Rankings and World Life Expectancy. The leading cause of death in Clarion County is heart disease. Cancer is the second leading cause of death, then accidents coming in third.

The heart disease mortality rate is 231.72 per 100,000 people, which is significantly higher than Pennsylvania and the US Median. Coming in at 172.91 and 161.52, respectively.

The cancer mortality rate is 182.01 per 100,000 people, which again is higher than the Pennsylvania and US Median coming in at 153.45 and 146.15, respectively. The age-adjusted rates in Clarion County for many cancers are higher to the rates of cancer incidence in Pennsylvania.

An area of interest, is that Diabetes is significantly higher in Clarion County compared to Pennsylvania and the US. The mortality rate for diabetes is 34.03 per 100,000 people for Clarion County. While Pennsylvania and the US diabetes rates are 20.37 and 21.59 per 100,000 people, respectively.

According to the County Health Rankings, Clarion County is ranked 32 out of 67 in both health factors and health outcomes (1 being the healthiest and 67 being the unhealthiest). In the health outcomes, Clarion County ranked 50% to 75% in the higher middle range of counties in Pennsylvania for health outcomes. For health factors, Clarion County ranked in the lower middle range at 25% to 50 (0% being the unhealthiest and 100% being the healthiest). County Health Rankings also identified areas of strength for Clarion County, which include teen births, uninsured, and high school completion. Some areas of improvements were adult smoking, adult obesity, and access to exercise, flu vaccinations, and unemployment.




Figure 2: Social Vulnerability Index

- <u>Social vulnerability:</u> is a community's capacity to prepare and respond to the stress of hazardous events ranging from natural disasters to human threats.
- There are four themes that summarize the SVI, which are socioeconomic status, housing/transportation, family characteristics, and language/race/ethnicity.
- The figure on the left is the overall SVI. This combines all the themes to show a comprehensive assessment.
- This data was collected in 2018 and the overall SVI for Clarion County was 0.4771, which is on a 0 to 1 scale. With 0 being the lowest vulnerability and 1 being the highest. Having a 0.4771 SVI indicates a low to moderate level of vulnerability.
- Socioeconomic Status and Housing Type/Transportation have the highest vulnerability within Clarion County.



PAYS Data Analysis

The Commonwealth of Pennsylvania conducts the Pennsylvania Youth Survey. Or PAYS, every two years. This surveys students' behavior and knowledge around alcohol. Tobacco, drugs, and violence. It also captures the students' mental health at a county and state level. A number of stakeholders mentioned the increasing issue of substance abuse and mental illness among the adolescents and young adults in Clarion school. PAYS also provides qualitative data to support the issues. The following graphs compare 2019 PAYS data from the Clarion County and Pennsylvania.




Figure 3: PAYS- Percentage of students who have felt depressed or sad most days in the past 12 months

- The county average for 6th through 12th graders who have felt depressed in the past 12 months is higher than the state for the same grades.
- Depressive levels for the county increase significantly among 10th and 12th graders, which a 10% increase for 10th graders and a 6% increase for 12th graders compared to the state.
- 51% of the county 10th graders reported that they felt depressed or sad most days.




Figure 4: PAYS- Self Harm within the past 12 months

- For 12th graders, the county average is around the same as the state average for self-harm.




Figure 5: PAYS- Percentage of students who have considered suicide within their lifetime

- Around 20% of students in 10th and 12th grade in Clarion County have considered suicide.




Figure 6: PAYS- Percent of students who have attempted suicide

• The percentage of students who have attempted suicide is less than the average of students who considered suicide, the county rates for all grades except for 12th are lower than the state average.




Figure 7: PAYS- Percent of students who reported use of cigarettes in their lifetime

- Almost 40% of students in the 12th grade have reported using cigarettes in their lifetime.




Figure 8: PAYS- Percent of students who have used Vapes/E-Cigarettes in the past 30 days

• Reported Vape/E-Cigarette usage in the past 30 days is much higher in Clarion County than the state for all grades.




Figure 9: PAYS- Percent of students who reported using smokeless tobacco in their lifetime




Figure 10: PAYS- Percent of students who have consumed alcohol within their lifetime

- The 6th grade consumption of alcohol in Clarion County is significantly higher than the state average.




Figure 11: PAYS- Percent of students who reported using marijuana in their lifetime

• 6th and 10th grader students reported rates of marijuana use are higher than the state average, while the other grades are lower than the state average.




Figure 12: PAYS- Percent of students in Clarion County reporting other drug usage during their lifetime




Figure 13: PAYS- Percent of students in Pennsylvania reporting other drug usage during their lifetime

- Most of the other drug usage from Clarion County aligns with Pennsylvania. However, cocaine usage in Clarion County is significantly higher than state usage.




Community Survey

To reach as many community members as possible within different groups. BHS Clarion distributed the survey using a range of methods. Electronic surveys and paper surveys were given out. BHS Clarion promoted the community survey through focus groups, emails, and office visits. The online version could be accessed from the link or QR code, which was the main source of incoming surveys, while paper surveys were given out where there was limited internet access.

The BHS Clarion employees who lived in Clarion were also asked to fill out the community health survey. The community survey was also distributed to outpatient physician offices for additional data collection. BHS Clarion collected 323 surveys that were completed by the community members. The survey consisted of questions relating to the individuals health status and overall community's health status, along with other factors linked to health. Like, demographics and fresh food consumption. The following is a summary of the results found through the community survey.




Figure 14: Community –Personal health status

How would you rate the health status of the community?




Figure 15: Community – Health status of the community

Do you currently smoke or use e-cigarettes (Vape pens, Juul, etc.)?





Figure 16: Community – Individuals that smoke or use e-cigarettes (Vape pens, Juul, etc.)

• Around 14% of the Clarion Community smoke or use e-cigarettes, while the remaining 86% individuals do not.






Figure 17: Community – Routine check up

Do you have any kind of health care coverage, including health insurance, prepaid plans, such as HMO's or government plans such as Medicare?




Figure 18: Community – Health care coverage




Figure 19: Community- Health Problems






Figure 21: Stakeholder – Overall Health Status

In your opinion, what is the most prevalent disease, condition or health issue the community is facing?





Figure 22: Stakeholder – Most Prevalent Disease

 According to the Stakeholders, heart disease and diabetes are the top health issues in the community.






Figure 23: Stakeholder – Top health needs

Focus Groups

BHS Clarion Hospital hosted focus groups with members of the community, healthcare experts from BMH and BHS Clarion, and the community health needs assessment team. The purpose of these focus groups was to review the primary and secondary data collected from surveys to help evaluate opportunities for growth. These focus groups help generate ideas and relationships for how BHS Clarion Hospital might be able to address the identified issues. The groups consist of school personnel, college students, behavioral health representatives, and pastors.

The first focus group was school personnel to talk about the students and their needs. The focus group meeting was held on April 6th, 2021. This group consisted of 6 people total, which included: 2 school social workers, 1 guidance counselor, 1 superintendent, 1 special education administrator, and the executive director from the IU6. The group rated the population's health as fair. A consistent message throughout the meeting was the lack of appropriate child care. This stems from the lack of access to resources, which includes: food, transportation, exercise opportunities, and mental/physical health services. The food resources in the community are limited due to the fact the food bank is only open during work hours and there are limited grocery store options. The lack of transportation makes it hard for families to get food or get to the YMCA to enroll in after school programs and exercise opportunities. There is a lack of appropriate child care because the families have skill deficiencies, which makes it hard to get resource information to those families. All of these factors have impacted the health of the children in the community, which have led to high rates if obesity and diabetes.

Potential solutions that were brought up at the focus group meeting was to increase the families' knowledge of resources through education and awareness, obtaining partnerships and connecting a network of resources for the families within the community. Also, creating a streamline of ER referrals to decrease the wait times for mental health services, and to work on food distribution initiatives to ensure healthier food options for the children and their families to reach a better health status.

The second focus group was college students, which was held on April 7th, 2021. This group consisted of 21 college students who attend Clarion University and are currently living off campus, which many have lived in the community for several years. These students gave an overall community health status as poor (7), fair (2), and good (5). These good ratings come from the fact that most college students and faculty are relatively in shape, along with a lot of blue collar workers in the area, which is a physically demanding workforce. Also, there are a lot of outdoor activities available for faculty and students. The students that rated it fair or poor are from the excessive drinking and tobacco use issues on campus. This leads into the biggest community health issues, which are tobacco use, mental health, and the drug use due to easy access. The reason for these issues is due to the lack of things to do, limited health food options, lack of community resources, and lower incomes within the community, which inhibits access to healthy foods and health services.

Potential solutions discussed to improve the community health within this population is to increase attractions and businesses to the area, have the university promote good health strategies, plan more events through the university activities board. These ideas can be promoted through social media, which could potentially help increase the overall health status of the college students and faculty.

The third focus group was the behavior health, which was held on April 12th, 2021. The group consisted of Director of Nursing at Clarion Psychiatric Center, CEO for Clarion Psychiatric Center and the Executive Director for the Armstrong, Indiana, and Clarion Drug and Alcohol Commission. These individuals rated the overall community fair (2), and good (1). Factors that are impacting the overall health to receive a "fair" health status are the obesity rates, poor hygiene, isolation, fatigue, lack of healthcare visits, financial stress, and poor diet. Factors that are impacting the overall health to receive a "good" health status are the physical activities available due to outdoor and recreation centers.

There are several community health needs, which are chronic mental health illness, chronic health conditions from heart to drug and alcohol abuse. Many individuals in the community are turning to alcohol for pain management because of the controls that are put on opiates, which has also increased drug usage like meth and opiates. There has also been an increase in marijuana use within the youth population along with vaping/e-cigarettes. Factors contributing to these health needs are the lack of access to transportation and the internet, lack of outpatient mental health services, and poor availability of placement for the mentally ill. There is also a lack of nurse navigation when trying to close the gap between mental and physical health. Other factors include: outlying areas outside Clarion have difficulty getting placed in a drug and alcohol recovery center because there is already a lack of D&A recovery programs. Overall, these issues are arising die to the lack of qualified providers in the area.

Potential solutions discussed to improve these community health needs is to work with the community on opening more transportation options; like Uber and "Rides for Recovery", along with introducing educational campaigns to breakdown the stereotypical ideas of behavioral health. Introducing behavioral health services and education to schools to provide assistance to



students and to encourage the students to explore behavioral health careers. Lastly, is using the HRSA for grants to provide services around mental health and drug and alcohol programs.

The fourth focus group were the pastors and the meeting was held on April 14th, 2021. There were 8 pastors that participated in the focus group meeting. Majority of the pastors rated the overall community health status as "fair." This contributed to the mental health issue, along with the lack of access to the YMCA, food insecurity, and high poverty rates. The government places many people in Clarion County that quality for section 8 housing and are essential placed there with no jobs, no income, and bad mental health, and usually suffer with drug and alcohol addiction. These people do not have the access nor have the required support services to obtain jobs or to receive help. It was also started that the schools are seeing more poverty stricken houses and are usually broken. "Broken" referred as having one or no parents, mental and physical abuse, lack of hygiene, and food insecurity leading to obesity and other health issues. The community as a whole also lacks the essential life skills to be successful and self-efficient. Many of the community members suffer from homelessness. Overall, there is a lack of coordination among community based social service and support service agencies with no linkage to help those in need navigate the services to address all of the social illnesses which lead to health crises.

Potential solutions that were discussed among the pastors and community health needs assessment team were increasing access to transportation, create a spiritual component to wellness programs and make referrals within the Lifestyle Medicine Institute. Expanding the concept of mobile health and wellness and to develop a training curriculum for church members to learn more about wellness. The goal is to train the volunteers so they will be able to train other community members on healthy food, mental health, exercise, and etc.


